Applications are invited for empanelment of Mediators for the Chandigarh State Consumer Mediation Cell, U.T., Chandigarh, attached with the State Consumer Disputes Redressal Commission, U.T., Chandigarh for mediation in the consumer cases from;

- (i) retired Judges of the High Courts,
- (ii) retired Members of Consumer Commission,
- (iii) retired District and Sessions Judges, retired Additional District and Session Judges or other retired Members of the Higher Judicial Services of a State,
- (iv) retired judicial officers, having experience of not less than ten years;
- (v) an advocate with a minimum experience of ten years at Bar;
- (vi) the mediators empanelled with the Mediation Cell of Supreme Court of India, High Court or a District Court;
- (vii) a person having experience of at least five years in mediation or conciliation and
- (viii) experts or other professionals with at least fifteen years experience or retired senior bureaucrats or retired executives;

Mediators will be empanelled in terms of section 75 of The Consumer Protection Act 2019, The Consumer Protection (Mediation) Rules, 2020 and The Consumer Protection (Mediation) Regulations 2020. The terms and conditions of the Mediators/Mediation Cell shall be, as referred in the relevant provisions of the Act, Rules and the Regulations which may be gone through by the desirous candidates.
